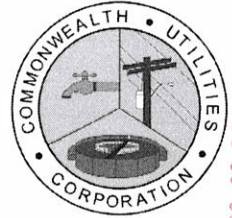

The Commonwealth Utilities Corporation (CUC) is hereby notifying all prospective bidders of the following amendments to CUC-IFB-18-004:

➤ **Bid Submittal Deadline:**

Box 501220, Dandan, Saipan MP 96950, **no later than 10:00 a.m. (ChST) on January 26, 2018.** at which time they will be publicly opened and read aloud. Bids mailed via postal or courier service must be received on or before due date and time. Bid shall be submitted on the provided Bid Forms. Bids will be required to be submitted under a condition of irrevocability for a period of 60 days after submission. ➤ **Deadline for Submission of Questions or Requests for Clarification:**

*The deadline for submission of questions or requests for clarification has been extended from 10:00 AM (ChST) on December 28, 2017 to **10:00 AM (ChST) on January 10, 2018.***
